Regarding the claims from Olle Johansson in recent mails to this list, I hereby ask Olle Johansson, to reply to the following questions (mainly regarding claims in the email dated July 29):

- 1. Who was the collaborating partner at the Hematological Centre at Karolinska Hospital that according to your claim "completely failed" to replicate the findings regarding red blood cell clumping? Please provide names and date for the complete failure so that this assertion can be verified.
- 2. Please send published full study from the Netherlands that also "completely failed" to replicate findings of red blood cell clumping.
- 3. During what time period were you "responsible for the blood and bone marrow cell teaching, incl. microscopy, at the medical teaching program" at your department? Please also provide name of your department.
- 4. You asserted that you "also contacted a number of similar hematological centers and asked them if they allowed patients, relatives, and staff to expose themselves to cell phone radiation before, during and after blood and bone marrow tests, and they said "yes". I then asked them if they ever observe any such cell phone-dependent clumping as can be seen in YouTube videos, and they said "no"." Please provide time period for these contacts and names of contacted persons.
- 5. Further regarding claim that you asked "the representatives of different hematological departments/centers if they see a general increase of Rouleaux phenomena in the population, and they said "no". (Such Rouleaux phenomena are well-known, both in teaching as well as at the clinical level, so if an increase in the general population would develop it would immediately be picked up.)" Please provide time period for these contacts and names of contacted persons.
- 6. Yet further you asserted that you "called clinical physiological laboratories routinely doing various cardiological examinations, incl. ECG readings, and asked the same: if they allowed patients, relatives, and staff to expose themselves to cell phone radiation before, during and after the various cardiological tests, and they said "yes". I then asked them if they ever observe any unexplainable HRV alterations, perhaps due to the RF exposure, and they said "no"." Please provide names of those persons that you contacted and time period for the contacts.
- 7. Regarding your claim that you "under the supervision of dear Magda, also tried to replicate the HRV results using orthostatic tests as the internal control, and with equipment meeting technical EMC standards. The internal control worked perfectly well every time, completely in accordance with textbook character, but we were completely unable to see any effect on the HRV from cell phones, WiFi routers, DECT phone base stations, and more, in our controlled studies." Please provide written report of these negative results (the methodology used, persons in charge of study, number of tested individuals, results etc.) and an explanation why this study was never previously published in a scientific paper. You received, according to my

- sources, 800 000 Norwegian Crowns from Norway in 2014 to perform this replication of Magda Havas results on HRV.
- 8. Last year, on May 26 2020, to the members of this list, you claimed that you performed an enquiry and collected 1200 answers in Stockholm: "I did together with a few friends was to position ourselves down at the Stockholm Södra and Stockholm City commuter train stations during rush hours, and performed a pilot questionnaire about these issues. We only collected slightly more than 1,200 answers, but at least all of them clearly answered that particular question with a "Yes, I want to have more, bigger, faster, more powerful, quicker a cell phone system"." Please provide explanation to the purpose of this time consuming effort, on whose behalf this was done, if it was funded and if so by who and by how much, and a report of asked questions, answer options, total number of approached persons, response rate and more detailed results of the enquiry. Please clarify if this and several of the other above quoted enquiries are included in your official research plan and a result of funding to your bank account through various websites around the world?
